GLAS 320 WHITE is used in textile construction, public buildings, exhibition stand and theatre construction, partition walls, illuminated ceilings.

The surface mass of the glass-fibre fabric coated on one side with white polyurethane GLAS 320 WHITE is about  $275 \text{ g/m}^2$ .
