2.1. General

STRETCH 300 FR is a polyester fabric used as an illuminated ceilings, sound absorption, pop up displays, backlighting, exhibition stand and theatre construction, printing media.

2.2 Product description

The surface mass of the uncoated polyester fabric STRETCH 300 FR is about 185 g/m². The fabric is produced by Stottrop-Textil GmbH & Co. KG.
